A RESOLUTION REGARDING SPENDING OF THE MUNICIPAL REGISTRATION FEE FUNDING

WHEREAS, Wisconsin State Statutes 341.35 Municipal or County Registration Fee Sec. 6(r) Use of Fee Proceeds states that "any municipality or county receiving moneys under sub. (6) shall use the moneys only for transportation related purposes; and

WHEREAS, Village of Bellevue passed Ordinance 0-2019-01 during the January 9, 2019 regular meeting to raise vehicle registration moneys for the purpose of offsetting moneys borrowed for local road improvements; and

WHEREAS, Village of Bellevue will, by the end of calendar year 2019, collect \$74,953 in excess of the projected \$93,000 in vehicle registration fee moneys, as described in the 2020 proposed operating budget for Village of Bellevue; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Village Board of the Village of Bellevue hereby authorizes that the \$74,953 vehicle registration fee moneys projected in excess of the originally projected \$93,000 be applied to the Debt Service Fund in the 2020 budget for the purpose of relief of tax levy supported debt that resulted from the tax levy supported special assessment subsidies.
