**RESOLUTION REVISING THE BOND SCHEDULE FOR THE VILLAGE OF

**WHEREAS**, the Village of Bellevue maintains a Bond Schedule (Schedule of Deposits) which includes recommended forfeitures for violations of the Code of the Village of Bellevue; and


