

**VILLAGE OF BELLEVUE  
RESOLUTION # V-07-2016**

**A RESOLUTION REGARDING SPENDING OF THE EXCESS GREEN BAY/BROWN COUNTY  
PROFESSIONAL FOOTBALL STADIUM DISTRICT SALES TAX FUNDING**

**WHEREAS**, 2015 Act 114 provides a mechanism for football stadium district sales taxes collected or imposed between April 1, 2015 and September 30, 2015 to be paid back to Brown County and municipalities within Brown County; and

**WHEREAS**, The Village of Bellevue's portion of the above stated revenue received to date is \$768,910.53; and

**WHEREAS**, Wisconsin Statutes specify how this funding must be deposited and used; and

**WHEREAS**, State Statute §77.76(5)(b)2, states that each municipality shall deposit the payment received into a segregated account established and controlled by the municipality to use only for the purpose of providing property tax relief, tax levy supported debt relief, or economic development. A municipality may not make expenditures from the segregated account unless the municipality adopts a resolution specifying the purpose for which the revenues will be spent and the amount of the revenues to be spent for that purpose; and

**WHEREAS**, 2015 Act 114 also provides that each year on October 1, the Department of Revenue will distribute any additional amounts collected after September 30, 2015; and


**NOW, THEREFORE, BE IT RESOLVED**, that the Village Board of the Village of Bellevue hereby approves establishing two segregated accounts titled "Committed Fund Balance for Stadium Tax" retroactive to December 31, 2015 within the Debt Service Fund of \$727,680.49 and within the General Fund of \$41,230.04.

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, that the Village Board of the Village of Bellevue hereby authorizes that \$727,680.49 of Excess Stadium Sales Tax Funding from the Debt Service Fund shall be for the purpose of tax levy supported debt relief.


